

Limited Warranty

(A) Dlubak Corporation warrants to the original purchaser only that the work performed by it as specified on the sales order will be free from defects in workmanship for the specified warranty period from date of completion of the work performed by Dlubak; provided, however, buyer must notify Dlubak of any defect within the specified warranty period. Dlubak will repair or replace the defect in workmanship covered under this limited warranty, or may, at its sole option, refund the amount paid by buyer with respect to the defective work.

(B) Dlubak warrants all laminating work against de-lamination in edge separation or obstruction of vision through the glass for a period of five (5) years from date of manufacture, provided, however, buyer must notify Dlubak of any defect within the warranty period. Dlubak will repair or replace the defect in lamination covered under this limited warranty, or may, at its sole option, refund the amount paid by buyer with respect to the defective work.

(C) Dlubak warrants all insulating work against moisture and condensation within the air-space for a period of ten (10) years from date of manufacture, provided, however, buyer must notify Dlubak of any defect within the warranty period. Dlubak will repair or replace the defect in insulating covered under this limited warranty, or may, at its sole option, refund the amount paid by buyer with respect to the defective work.

(D) If any workmanship is not in compliance with this limited warranty or any other implied warranty, the liability of Dlubak is limited to repair or replace of the defective product or refund of the amount paid, in the sole discretion of Dlubak. The remedy of repair, replacement or refund is the exclusive remedy available to the buyer. Dlubak shall not be liable for the loss of profits, loss of use of any product, loss of time, cost of capital, cost of substitute materials, inconvenience, cost of installation, cost of labor, cost of freight or delivery of replacements, commercial loss or any other indirect, special, incidental or consequential economic damages based upon breach of this limited or any applied warranty, breach of contract, negligence, strict tort or any other legal theory.

(E) This limited warranty does not cover defects in materials or failures from acts of GOD; abnormal weather conditions; unreasonable or improper use, abuse or handling; improper installation, mounting or fastening; abrasions or scratches to product; improper maintenance, cleaning or damage due to solvents, cleaners, acids, alkalis, or any chemical used on or around the Product; incompatibility with gaskets, setting blocks, sealants, coatings, lubricants or any other materials; faulty building construction or design; or improper handling or storage; provided, however, that defects in materials may be warranted separately by the manufactures of such materials.

(F) Dlubak reserves the right to inspect any product which is alleged to be defective. Buyer must provide access to product at Dlubak's convenience.

(G) This warranty applies only to products paid in full.

(H) Dlubak makes no other express representation or warranty of any kind. This warranty gives the buyer specific legal rights, and buyer may have other rights that vary from state to state. Any other rights that the buyer may have, including any implied warranty of merchantability or warranty of fitness for a particular purpose or use, is limited in duration to the duration of this warranty.

(I) If the product is found to be defective within this limited warranty, and the product is repaired or replaced, the warranty of the repaired or replaced product shall be limited in duration to the remainder of the warranty period of the original product.

(J) Dlubak assumes no responsibility for glass breakage or damage in transit. The buyer is responsible for processing any and all freight claims.

(K) This limited warranty is to the original purchaser and is not transferable.
